Our safeguarding framework

Our training is aligned with the Intercollegiate document (RCN, 2019)

What we have in place

- Designated Lead and Named Nurse for Safeguarding Children and PREVENT Lead
- Safeguarding Assurance Committee
- Extensive child and adult safeguarding policies, including Liberty Protection Safeguards
- Safer recruitment; including enhanced DBS checks
- All staff, volunteers and Trustees receive an introduction to safeguarding during their induction
- All staff, including non-clinical managers, and Trustees complete Level 1 safeguarding e-learning
- All staff, volunteers and Clinical Governance Trustees undertaking hospice related activities but not directly working with children and families undertake Level 2 safeguarding e-learning, and attend a face to face update every 3 years.
- Anyone working directly with children and families undertake Level 3 safeguarding training every 3 years, with an annual face to face update
- Designated Safeguarding and PREVENT Leads undertake Level 4 safeguarding training
- The Director of Clinical Services and Registered Managers undertake Level 5 safeguarding training
- Line managers attend safe recruitment training

What we do

- Safeguarding is an agenda item at the weekly clinical safety meeting
- Safeguarding is discussed at monthly MDT and safeguarding meetings
- Quarterly safeguarding audits are undertaken
- An annual safeguarding report is presented to the Clinical Governance Committee
- The safeguarding children and adults policy and procedure is reviewed annually
- The safeguarding assurance committee meet quarterly to review safeguarding practices
- Safeguarding is a standard agenda item at every Clinical Governance Committee meeting
- Safeguarding is a standard agenda item at every Trustee Board meeting
- Internal and external safeguarding supervision
